- 1925hrs – Yuelamu Clinic notified
- 1930hrs – Supt Nobbs contacted by FROST
- 1932hrs – HAND attempted to contact W/Commander. Nil answer on both landline and mobile
- 1935hrs – Luana SYMONDS contacted by FROST re medical retrieval team.
- 1940hrs – Medical retrieval team ASP spoken to by FROST – 1800167222 re coming to Yuendumu. U/K name of the Dr spoken to.
- 1942hrs – Comms supervisor spoken to and updated by HAND
- 1945hrs – NOBBS spoken to by FROST
- 1947hrs – Steve from the school rang station phone – advised there are a large group of men walking up past the school toward the police station.
- 1949 – TDS rang the station mobile. Spoke to FROST. U/K who the TDS was (from FROST)
- 1955 Timewell called ?? safety of teachers
- 1956 – HAND received a call from Comm WURST re situation. Appraised. He said he will arrange for Darwin / ASP Members to come to Yuendumu. Requested I speak with ACPO Derek Williams re: how this situation will play out. Sent WURST WILLIAMS' number
- 1958 – Dr rang – police on plane
- 2001hrs – TDO – RONNING-BURNS rang the On call phone to speak with FROST
- 2015 – 000 contacted using work mobile to talk with St Johns during resus
- 2040 – Critical Decision by NOBBS to transport the body out of the station and photograph the scene in the cells.
- 2041 – direction by NOBBS for all Police Staff to leave
- 2102 – direction received to stay at station.
- 2135 – crime scene log commenced with tape over the cell area
- 2203hrs – From Sgt FROST. Critical Decision from Det Leith PHILLIPS. Deceased to be placed in body bag.
- 2225hrs – Papunya Spoken to via sat phone. They are 80km from Yuendumu. Directed to ring Yuendumu when they are in mobile range for further details.
- 2230hrs – Info from FROST – PolAir in holding pattern waiting for Papunya to arrive to go straight to Airstrip
- 2245 – Handful of members left the station to travel to airstrip
- 2256 – Crews mobile from air strip returning to station.
- 2300 – arrived at the station. Clinic Nurse injured from rock throwing.

2305 – Eddie Robertson contacted main line in an agitated state asking if Arnold (grandfather of deceased) is alive or dead. HAND answered and advised ROBERTSON that I didn't have any information that I could give him and that I would get Sgt Frost to call him back. Mobile phone number taken.

2305 – FROST advised of the call. She was on the phone with ACPO Derek WILLIAMS at the time. WILLIAMS suggested that any information to the family should come from "Bosses" (Management)

2325 – Ashley Janssen from WYDAC contacted police to advise that the Yuendumu Clinic is on fire.

2350 – Sgt Zhang contacts Supt Nobbs regarding notification to family

1207 – phone call to Eddie Robertson by Terry Zhang – was told that Arnold is still receiving medical treatment. He said thankyou – give me a call.

1210 – Two outdoor Crime Scenes established in the Yuendumu Compound.

1245 - briefing provided by Terry Zhang re getting TRG from plane to compound

1248 – Members prepare for departure to airport

1250 – Det Kean ASP Investigations contacted station to advise they are at Tilmouth Well Roadhouse. He was instructed to make contact again when in range of Yuendumu Mobile reception to await instructions for entry into the Police Station compound

0115 – Mobile units clear of Station on way to airstrip.

0117 – wheels down Yuendumu

0130 – Members depart airstrip

0144hrs – TRG aircraft departed.

0149 – All members arrived at Yuendumu Police Station including TRG

0154 – Briefing with Team Leader TRG / OIC Yuendumu / Sgt Zhang

0208 – Contingent of TRG and uniform members to escort ASP Crime members to the station from the Tanami
